

Child Protection Manager Manager (Full Time: Berlin: 37 hours)

The Child Protection Manager (CPM) will focus on implementation of Child Protection Protocols (CPP) across the organization. The CPM makes use of innovative curriculum development, instruction methods and assessment tools to improve organizational understanding of CPP and to improve the organization's ability to respond to the social-emotional needs of its beneficiaries. The CPM works closely with the Director team, Programs Management team and national General Managers to implement policy assessments and improvements. The position's key focus area is promoting child protection and social-emotional support throughout the organization's programs, locations and departments.

This is a full-time position of 37 hours per week based at Skateistan's headquarters in Berlin, Germany - with a competitive salary, annual travel to project sites and generous holiday allowance.

Core Responsibilities:

Program Development

- Work with the Programs team to update existing Skateistan child protection policies and resources using Skateistan's communication platforms
- Lead development of additional policies, guidelines, systems, and tools where needed
- Support the Programs team with integrating child trauma awareness and psychological support into core programs, including the use of art therapy, debriefing, and structured self-reflection
- Work with the Programs Manager to ensure the organization's skateboarding and other athletic programs are safe, meaningful, and suitably challenging for students
- Support GMs and Programs team with implementation of procedures and improved reporting of Child Protection incidents
- Conduct analysis of child protection incidents, make recommendations to Skateistan, and track progress
- Develop and maintain national and international partnerships that strengthen the organization's ability to meet the emotional needs of students
- Work with Directors and the Programs Management teams to align Skateistan's policies with the Core Humanitarian Standard on Quality and Accountability (CHS) and relevant international standards, especially pertaining to protection
- Work closely with the monitoring, evaluation, and learning (MEL) Manager to assess the state of child protection and child well being across the organization's programs and locations, and improve the state of CPP based on learnings
- Conduct research on local needs and trends in the development sector around child protection

- Develop and support ongoing training of Community Educators at Skateistan Schools (responsible for student registration, liaising with families, local case management)

- Previous experience developing, implementing and monitoring a child protection protocol at the national and international levels
